Students are eligible for admission to the E. J. Ourso College of Business once they have successfully completed the following requirements:

- ▶ Complete a minimum of 30 hours of university coursework (students following the 2016-17 catalog and later must include 12 hours of coursework on the LSU A&M campus of which at least 9 hours must be from the E. J. Ourso College of Business).
- ▶ Complete the Pre-Business Core classes (ENGL 1001, MATH 1021 and MATH 1431, ECON 2000, ISDS 1102, and ACCT 2001) with a "C-" or better in each course. Students who place or test out of any of the Pre-Business Core classes will be given credit for successfully completing those classes.
- ▶ Achieve the minimum GPA (including LSU and business averages) for the selected major. See **website** for details.
- ▶ Students are responsible for meeting the requirements as listed in the catalog under which they are enrolled. The GPA requirements for each major are listed in the LSU online catalog (www.lsu.edu/catalogs). If you are unsure of your official catalog year, please contact us at advisor@lsu.edu.
