KEY FACTORS DRIVING PHASE 2

- Additional modification to state and parish guidelines for physical distancing
- Phase 1 completed for at least two weeks
- LSU Presidential directive

PERSONNEL INCLUDED IN PHASE 2

Colleges and administrative units shall identify any additional personnel who may return to campus in Phase 2 and under what weekly schedule, then submit that information to the EOC. The respective Executive Vice Presidents shall review and, if appropriate, approve.

GOVERNING DIRECTIVES FOR PHASE 2

- Work that can be done while telecommuting should still be done from home.
- Only those approved for Phases 1 and 2 will be allowed back on campus.
- Campus will remain operational on a limited capacity.
- Some buildings, as well as all common areas/social gathering spots, remain closed.

- For those returning to campus, physical distancing required by state/parish/city orders must be followed and **face coverings must be worn if physical distancing cannot be maintained, including in public spaces.**
- In-person meetings remain limited to 10 people.

If you're sick, stay home and consult your health care provider.

Anyone who believes they have been exposed to COVID-19 should call a health care provider. If you have been diagnosed with COVID-19 please inform your supervisor and email reportcovid@lsu.edu.

LSU will initiate additional phases when Phase 2 has been completed successfully or when an LSU presidential directive is given.

Any concerns regarding returning to campus should be directed to your immediate supervisor.

LSU PHASE 2

EFFECTIVE THROUGH JULY 24, 2020

50% or less of personnel on campus while still maintaining current CDC physical distancing protocols

GOALS

The goal of this phase is to bring back additional personnel in a controlled capacity.

OVERVIEW

- Only personnel specifically approved by the EOC may return to campus
- Limited access to buildings; some offices remain closed
- Gathering spots remain closed
- University-sponsored activities will be virtual
- Employees must maintain CDC physical distancing regulations
- Face coverings should be worn by employees when the job or circumstances put them within 6 feet of others
- Anyone who believes they have been exposed to COVID-19 should see a health care provider and, if directed, shall self-quarantine for 14 days from the date of alleged exposure.

Office Environment

- Telework will continue for non-critical personnel
- Stagger workdays (MWF/TTH) for critical personnel in office work
- No in-person all-staff meetings
- Virtual meetings are preferable; small group meetings can be held face-to-face with all participants wearing masks and following established guidelines for sanitization

Academic Classroom

- Most classes will be taught remotely
- Faculty who cannot teach from home may request approval from their dean to teach from their office or lab

Camps and Events

- All on-campus camps and events are cancelled through the summer

Research, Labs and Studios

- Library may open for faculty and grad students only to pick up and return materials; digital delivery will continue
- Research labs able to open based on priority in consultation with the Provost's Office and the EOC
- Teaching labs remain closed
- Studios remain closed
- For those research labs that open:
 - ▶ High-touch surfaces should be disinfected regularly in accordance with LSU's COVID-19 Disinfection Protocols
 - ▶ Current CDC guidelines for physical distancing must be followed
 - ▶ Stagger workdays (MWF/TTH) for employees to maintain physical distancing

Residential Life

- Current status and operations remain unchanged

Student Affairs

- UREC opens on a limited basis on July 13, and adheres to physical distancing and sanitation protocols.
- Union remains closed to public
- Bookstore opens but limited curbside service

Dining

- Curbside operations maintained according to city/parish/state guidelines

Athletics

- Return to voluntary practice beginning June 8

Travel

- Non-essential domestic travel considered on a case by case basis; restrictions may apply
