_____ **Illegal activities,** including the use of alcohol and illegal substances in any facility on campus or in one of its associated facilities, will be grounds for removal from the camp and from campus housing, if applicable, without a refund.

_____ **Medical treatment.** The participant understands that LSU does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

_____ **Assumption of Risk.** The participant hereby expressly and specifically assumes the risk of injury or harm in the activities and releases LSU from all liability for injury, illness, death, or property damage resulting from the activities.

_____ **Photographic Release.** Participant does hereby grant and convey unto LSU all right, title, and interest in any and all photographic images and video or audio recordings made by LSU during the participant's activities during E², including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

_____ **Assessment Release.** The participant agrees to complete a survey and other assessment activities for the purposes of instructional feedback and for overall improvement of the E² program.
