1. Meeting was called to order at 8:10 A.M.
2. Minutes for October 1, 2008. Ann Holmes moved to approve the minutes. James Ryon seconded. Motion passed.
3. The following will be listed for what the Economics Department will accept from the AP examinations on page 47 in the LSU catalog.
  - a. AP Micro – a minimum score of 4 will get credit for ECON 2000.
  - b. AP Macro – a minimum score of 4 will get credit for ECON 2010.
  - c. IB credit Economics – a minimum score of 5 will get credit for ECON 2030. (page 49)

Ann Holmes moved to approve the above scores. James Ryon seconded. Motion passed.

4. Continued enrollment in the E.J. Ourso College of Business is dependent upon satisfying the following requirements:
  - Maintain an overall gpa of 2.5 on all university course work.
  - Maintain a minimum 2.5 business gpa.
  - Maintain satisfactory academic progress towards completion of degree.

**Mandatory Advising**

A student will be required to meet with an academic advisor in the Dean's Office for the following reasons:

- The student's overall gpa falls below a 3.00 at the end of any academic semester.
- The student's business gpa falls below a 3.00 at the end of any academic semester.
- The student fails to make satisfactory academic progress towards the completion of the degree.

A student will be dropped from the E.J. Ourso College of Business for the following reasons:

- Students whose overall gpa falls below a 2.50.

James Ryon moved to approve the above requirements. Alvin Burns seconded. Motion passed.

5. The following response to the Faculty Senate Executive Committee's request to investigate "Full Folder Review" was drafted.

The Office of Undergraduate Admissions and Student Aid affirmed to the Admissions, Standards, & Honors Committee that any future changes to admission requirements and major philosophical shifts in LSU's mission that could affect our incoming class profile will be administered only with the approval of Admissions, Standards, & Honors Committee; Faculty Senate Executive Committee; and Faculty Senate. There is a Faculty Admissions Committee that currently consists of Bill Grimes, Music; Paul LeRoc, Oceanography; Karl Roider, History; and Linda Smith Griffin, Library Science. These faculty review all of the folders for students not meeting the published LSU admission standards. The faculty is well involved in the process. ASH recommends that the Faculty Admissions Committee be a standing committee whose membership will be suggested by the Office of Undergraduate Admissions and Student Aid and approved by the Faculty Senate Executive Committee.

James Ryon moved to approve the above statement. Terry Buchanan seconded. Motion passed.

6. Information describing the comprehensive academic tracking system was distributed. A Preliminary discussion began. It was decided that a member of the University CATS committee be invited to the ASH meeting on November 12<sup>th</sup> to brief the committee about CATS.
